## BRANCH TOWNSHIP ORDINANCE NO. 99-4

- Section 1. This Ordinance shall be known as an Amendment to the **Branch Township Traffic Control Ordinance** of Branch Township, Schuylkill County, Pennsylvania.
- Section 2. In accordance with the reasons initially set forth in Ordinance No. 91-4 known as the Branch Township Traffic Control Ordinance, it is has been deemed necessary to regulate the speed limit at certain roads within the Township.
- Section 3. It is hereby authorized and directed that Silverton Road in the Village of Llewellyn have a speed limit of 15 miles per hour.
- Section 4. It is hereby authorized and directed that Phoenix Park Road in the Township have a speed limit of 25 miles per hour.
- Section 5. It is hereby authorized and directed that the appropriate signnage be erected in accordance with the specifications set forth by the Pennsylvania Department of Transportation to establish the speed limit for those traffic ways.
- Section 6. Any person who violates any provision of the Branch Township Traffic Control Ordinance, as amended, shall be prosecuted under the applicable sections of the Motor Vehicle Code and fined in accordance with the existing law, together with costs of prosecution and any other assessments permitted.
- Section 7. Effect of Amendment
  This Ordinance serves to amend the Branch Township Traffic
  Control Ordinance, No. 91-4, originally enacted on December 16,
  1991, only to the extent stated and the Branch Township Traffic
  Control Ordinance of 1991, as amended, remains in full force and
  effect in all other aspects.
